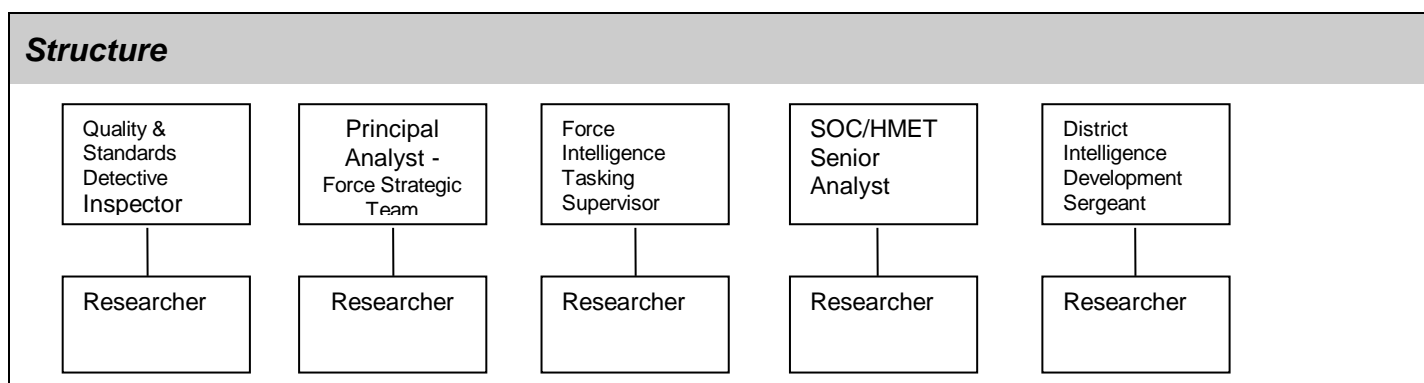

Research, retrieve and present information in an appropriate and corporate format. Using a diverse range of computer and manual internal and external data sources intelligence, information, incidents and crimes to assist in the identification of links and associations between data.3. Monitor and maintain ongoing products updating as and when necessary to ensure that both intelligence and operational staff have all relevant information available.4. As directed by supervision assist in the preparation of analytical products by researching information and providing relevant and timely information5. Where required provide research support to the District/Department in support of discipline matters.6. As directed by supervision conduct live time research to support ongoing operational activity.7. Contribute to department briefings and attend meetings, as required, to ensure that relevant intelligence is disseminated to operational staff effectively.8. Ensure that any information gathered from contact with other forces and agencies is submitted or disseminated as appropriate in an accurate and timely fashion ensuring compliance with the Management of Police Information (MOPI).
