- 7. Liaise, monitor and work with Digital Policing supplier's staff to perform work to the Directorate's quality standards and operating procedures.
- 8. Assist in the development of complex Digital Policing solutions and infrastructures to deliver Projects as directed. Assisting with the development and support of all aspects of the Force's Server, Storage, Monitoring, Operating Systems, Virtualisation and Thin Client environments.
- 9. Responsible to seek professional advice/guidance/knowledge from within the department or suppliers to ensure quality and correctness in undertaking any duty.
