Part A - JOB DESCRIPTION

Overall purpose of role

To enforce, by the use of mobile and fixed speed recording equipment, the speed limits on designated roads.

Key outputs for role -

- 1. Lead by example and behave in line with the Police Code of Ethics ensuring that the force values and behavioural expectations are clearly understood and considered by managers, officers and staff in their decision making and actions; reinforcing and influencing them through all interactions and processes.
- 2. To conduct mobile speed enforcement at locations identified by the Partnership as speed or casualty hotspots, using type approved speed detection devices linked to recording equipment.
- 3. Whilst conducting speed enforcement activity identify other serious road traffic offences, recording sufficient evidence to enable these to be dealt with by the Police.
- 4. To conduct pre enforcement checks of road signage at identified locations to ensure lawful enforcement can take place.
- 5. Liaise where necessary with the Local/Highway Authority to ensure any deficiency in signing or other factors affecting safety are brought to their immediate attention.
- 6. Attend/liaise with outside agencies and the Safety Camera Partnership to survey new or faulted mobile sites in compliance with ACPO codes of practice, Health & Safety Regulations.
- 7. Present expert evidence at Magistrates and Crown Courts in relation to all areas of mobile Safety Camera Technology and enforcement covering the West Yorkshire area to aid the judicial systems in criminal proceedings.
- 8. To attend and promote Casualty Reduction at specific events ensuring compliance with Health & Safety legislation.

- Enforce at targeted sites to reduce road casualties, working independently without direct supervision throughout West Yorkshire.
- As part of a team processing camera detection offences.
- To comply with Data Protection, Official Secrets Act, Freedom of Information, ACPO Codes of Practice and Force Policy.
- Contributing towards the department achieving its performance targets and priorities.
