Part A - JOB DESCRIPTION

Overall purpose of role

To provide a comprehensive, efficient and effective crime scene examination service to police investigations by attending volume crime scenes.

Key outputs for role -

- 1. Lead by example and behave in line with the Police Code of Ethics ensuring that the force values and behavioural expectations are clearly understood and considered by managers, officers and staff in their decision making and actions; reinforcing and influencing them through all interactions and processes.
- 2. Support and engage in the relevant quality management system/s to ensure organisational conformance with the standards required by the Forensic regulator
- 3. Prepare for operational deployment to incidents in line with departmental procedures, checking vehicle, consumables, operational equipment is ready for use and interrogating relevant force systems to assist in the crime scene examination process.
- 4. Attend incidents and scenes of crime, during attendance communicate with members of the public, complainants or victims, often when they are distressed or potentially hostile, in an attempt to establish the circumstances, or a sequence of events.
- 5. Attending Volume Crime Scenes (burglary dwelling, burglary other, vehicle crime, criminal damage, injury photographs and recovered property) as primary examiner utilise the information available in the request and from people in attendance to develop a scene examination/ evidence recovery strategy that meets the investigative requirements.
- 6. Record, recover and package digital imaging evidence, primary identification evidence, trace evidence and artefacts from scenes in line with the determined recovery strategy, identifying the correct techniques and sequence of examination to maximise the forensic potential that exists within an examination scene, avoiding loss of evidence or contamination.
- 7. Produce accurate and comprehensive scene examination reports in line with departmental protocols, and update information onto the RSS case management and other force systems as required.
- 8. Produce criminal justice statements detailing the examination completed and evidence recovered, and where required attend coroners, crown or magistrates court to give evidence as a professional witness.
- 9. Attend scenes as required and deliver all or part of a documented scene examination strategy (this could be any crime type where the examination requirements are within the competency requirements of the role or individual).
- 10. Provide specialist advice to colleagues and police officers on scene preservation, examination requirements and techniques, and exhibit packaging and submission to ensure forensic opportunities are maximised at volume crime.

Dimensions (Financial/Statistical/Mandates/Constraints/No. of direct reports)

- The CSI role provides a service as primary examiner to predominantly Volume Crime burglary dwelling, burglary other, stolen/recovered vehicles, injury photographs, criminal damage and recovered property. When required will assist in the examination of other crime types as requested, if the examination requirements are within the individuals skills/role competency.
- This service is provided 7 days per week covering 7am to 11pm.
- This role contributes to the total number of scenes attended per year by the CSI Unit of about 55,000


